**ACKNOWLEDGMENT AND UNDERTAKING
TO RESIGN AND NEVER REAPPLY**

I, **NICHOLAS DALLAIRE**, hereby acknowledge and undertake as follows:

1. I acknowledge that I am a member of the Nurses Association of New Brunswick ("NANB") and that my certificate of registration was suspended by way of interim order on April 2, 2024.
2. I acknowledge that on or about November 2, 2023, NANB received an e-mail from Assistance Services Group alleging that I provided negative and inaccurate information about COVID-19 vaccines to a pregnant patient while working as a Tele-Care Registered Nurse in October 2023 (the "Complaint"), which caused NANB to commence an investigation into my conduct.
3. I acknowledge that the Complaint was referred by NANB's Complaints Committee to its Discipline Committee on April 2, 2024.
4. I acknowledge that I am entering into this Acknowledgment and Undertaking in exchange for NANB not proceeding with a discipline hearing against me as long as I comply with this Acknowledgement and Undertaking.

Resignation with Undertaking to Never Re-Apply

5. I undertake to resign my membership and certificate of registration with NANB immediately upon the signing of this Acknowledgment and Undertaking.
6. I acknowledge that after I sign this Acknowledgement and Undertaking, NANB will hold the Complaint investigation against me in abeyance and will not hold a discipline hearing into my conduct unless I breach this Acknowledgement and Undertaking.
7. I undertake never to re-apply for membership, registration, licensure, or similar status as a nurse with NANB.
8. I acknowledge that once my resignation is tendered, I will not be entitled to use the titles "nurse", "registered nurse", "N" or "RN", or any abbreviation thereof or equivalent in another language, I will not be entitled to hold myself out as a person who is qualified to practise in New Brunswick as a nurse or in a specialty of nursing, I will not be entitled to imply that I am a nurse

or engage in the practice of nursing in New Brunswick, and I will not be entitled to engage in the practice of nursing .

9. I acknowledge that if I ever apply for membership, registration, licensure, or similar status with NANB in the future, NANB will be entitled to rely upon this Acknowledgment and Undertaking in any registration or licensure proceeding as reason to deny my application.
10. I acknowledge that if I ever apply for membership, registration, licensure, or similar status with NANB, or if I breach this Acknowledgement and Undertaking in any way, NANB will also be entitled to rely upon this Acknowledgment and Undertaking to institute professional misconduct proceedings against me for breach of this Acknowledgement and Undertaking.
11. I further acknowledge that if I ever apply for membership, registration, licensure, or similar status with NANB in the future, NANB will also be entitled to reinstitute the investigation into the Complaint and prosecute the case against me at a discipline hearing and NANB will be entitled to rely upon this Acknowledgment and Undertaking for those purposes.
12. I acknowledge that such investigation and/or prosecution into my conduct as a result of my breach of this Acknowledgement and Undertaking may proceed in accordance with the *Nurses Act* (1984 amended in 1997 and 2002) or its successor, even though I have resigned my registration with NANB.

Other

13. I acknowledge that NANB will include the full text of this Acknowledgment and Undertaking on the public register of NANB, which is located on NANB's website, along with a notation of the fact that I entered into an undertaking to resign and never re-apply.
14. I further understand, acknowledge, and agree that:
 - a. I fully understand the terms of this Acknowledgment and Undertaking;
 - b. I am signing this Acknowledgment and Undertaking voluntarily and without compulsion or duress; and
 - c. I have either obtained independent legal advice prior to signing this Acknowledgment and Undertaking or I have knowingly waived my right to do so.
